

The number of corporations taxed has increased from year to year both through discovering new corporations under the old provisions of the law, and by adding new classes of corporations. License fees on foreign corporations were imposed in 1895, and still later saving banks were brought under the provisions of the statute. In 1912, report blanks were sent out to over 40,000 separate corporations. The work connected with the taxation of so many corporations grew from that which could be performed by one clerk to a volume that required a large office force. In 1912 the corporation tax bureau employed sixteen salaried officials, including examiners located in the offices at New York and Buffalo. One reason the law worked so well was that large powers were conferred upon the comptroller in the matter of securing satisfactory reports from the corporations. He was given power to examine books, records and papers, to issue subpoenas requiring the appearance of persons, and such books and documents as might be necessary to determine the tax. The books of corporations which failed to report, or which made unsatisfactory reports, were examined by special examiners. In 1892, 189 corporations located in New York and Brooklyn were examined, and this work has now grown so as to demand a continuous staff of men for this purpose.
